



MAIN THEATRE RENTAL SCHEDULE

RENTAL RATES

SINGLE PERFORMANCE: Greater of **\$ 6,500.00** or **10%** of Gross Box Office Receipts (not including GST) up to a maximum of **\$14,000.00**

SINGLE PERFORMANCE - STATUTORY HOLIDAY: Greater of **\$ 7,025.00** or **10%** of Gross Box Office Receipts (not including GST) up to a maximum of **\$ 15,125.00**

TWO PERFORMANCES ON THE SAME DAY: Greater of **\$ 8,000.00** or **10%** of Gross Box Office Receipts (not including GST) up to a maximum of **\$ 22,500.00**

Plus \$2.35 per seat sold for all events PLUS GST AND CREDIT CARD CHARGES. *A minimum number of 1000 paid tickets are required. Should you not meet the minimum attendance, a surcharge of **\$2.35 PLUS GST** will be added to your settlement for all unpaid tickets up to 1000.

Your 12 hour facility rental includes:

- Fit-up and/or rehearsal time
- Performance time*
- Strike time
- Front-Of-House included for performance
- One (1) Stage Carpenter, one (1) Stage Electrician and one (1) Audio Technician for **eight (8) hours each**.

Rental also includes use of the Mainstage, Green room, Dressing rooms and Chorus rooms. All other **auxiliary spaces** will be charged per the current rate sheet.

****Performances held Monday – Saturday**

- Hours over **eight (8)** will be billed to you at **\$75.00 per hour** for each technician up to **12 hours**.
- Hours over **twelve (12)** will be billed to you at **\$100.00 per hour** for each technician.

****Performances held on Sunday**

- Hours over eight (8) will be billed at **\$100.00 per hour** for each technician.

To ensure no penalties, meal breaks should be given after four hours of work. Lack of a **1-hour meal break after 5 hours** will result in a **\$50.00 per hour for each technician additional charge** until a break is taken. **All activity on stage must be supervised at all times by House Technicians.** The total number of stagehands required to be determined by the House Technicians in consultation with the licensee.

Any additional technicians to set up or run your show will be supplied and billed through I.A.T.S.E

* If the **performance** runs **longer** than **three hours**, then the extra time shall be billed at **\$1,000.00 per hour or part thereof**.

Performance Intermission - At any performance exceeding one hour, excepting religious services and commencement exercises, the Licensee shall provide at least one 20-minute intermission. The Licensee shall pay the Minister an additional fee of **\$1,000.00** if there is no such intermission.

Cancellation of Performance - If for any reason the performance on the premises will not take place, the Licensee shall at its expense inform the public of this fact through normal media information sources. If the Licensee cancels a performance **within 72 hours** of the scheduled time of the performance, the Licensee shall pay the **full rental** amount required under this License Agreement as if the performance were to occur.
